THE OPPORTUNITY

FUTURE, the opportunity of every Canadian to have a job must be our next government's first priority. Only through secure employment will Canadians be able to regain their personal dignity and participate fully in our society. This is most urgent for women who continue to be denied equal access to job opportunities and for our youth who deserve a future of hope and not a future of despair.

Brian Mulroney and John Turner will continue to leave it to the corporate few.

In recent years, Liberal and Conservative governments have been taking tax dollars from ordinary Canadians to give more and more opportunities to banks and big businesses. In fact, corporations today are pocketing four times more in tax breaks than they were ten years ago.

These giveaways of public funds total more than \$25 billion a year — about the same as our total federal deficit — and take about \$1,000 from every Canadian.

Almost all the tax breaks are going to the largest corporations. In fact, less than one per cent of Canada's corporations get almost eighty per cent of the tax breaks.

The Liberals and Conservatives say the tax breaks will be used to create new jobs.

However, this massive national investment in our country's banks and big businesses hasn't give every Canadian the opportunity to work. We can create these opportunities by retraining our workforce, upgrading our natural resources, tapping the potential of new technologies and rebuilding our devastated manufacturing sector.

All we need now is a federal government with the political will to make full employment its most pressing priority.

Make technological change and shutdowns negotiable items. Minimize job losses from technological change through shorter hours (with no loss in pay), early retirement, longer holidays and flexible work arrangements. Increase advance notification period for technological change, shutdowns and layoffs.

The corporations have used the tax breaks in ways that makes sense to them: to raise their profits, invest abroad, finance takeovers and reward their shareholders. Unfortunately, none of these have created jobs.

Coming from the boardrooms of banks and giant corporations, they want to do what's best for the favoured few. But that won't distribute any opportunities to the rest of us.

In recent years, Liberal and Conservative governments have also taken away job opportunities from ordinary Canadians by letting our interest rates rise to levels set in the United States. Only the banks have benefited from these high interest rates — with opportunities to increase their profits even more.

They cannot continue to be the victims of these corporate decisions, particularly women who work in jobs most vulnerable to technological change. Corporations must negotiate the terms of technological change, layoffs and shutdowns with their employees and the community. Those corporations must share in the costs of layoffs and the benefits of technological change.

NEW OPPORTUNITIES FROM...LOW AND STABLE INTEREST RATES

- Set interest rates according to Canada's job needs, not U.S. policies.
- Discourage unnecessary investment outflow with a speculator tax.
- Establish long-term, stable mortgage rates for homeowners.

 Opportunities to get more jobs from lower, stable interest rates. Hundreds of thousands of new jobs would be created in Canada if our federal government ensured creating initiatives. New Democrats will continue the fight for an interest policy independent of the United States in order to create a stable climate for new job opportunities.

NEW OPPORTUNITIES THROUGH... SMALL BUSINESS

- Ensure banks provide more loans to small business at rates given to big business.
- Provide more risk and venture capital.
- Establish a more aggressive "Buy Canadian" program to include government contracts.
- Provide greater opportunities for women to establish small businesses.
- Make sure small business pays lower effective tax rates than big business.
- Eliminate this year's \$1.4 billion increase in federal consumer taxes.

 Opportunities to promote community sources of new jobs. Our new future must be one of expanded opportunities — extended to Canadians who are far away from corporate boardrooms: small businesses, farms, community and worker co-operatives, native communities, ethnic groups, and others. The initiative of these ordinary Canadians should be encouraged, and supported, by their federal government.

For men and women in one-industry towns and rural areas, the desire and des-

perate need to succeed almost guarantees that jobs will be created.

There are many examples — all across Canada — of communities, workers and small businesses who have taken over profitable enterprises which were abandoned by runaway corporations. The former owners pulled up stakes to seek even greater profits overseas.

NEW OPPORTUNITIES THROUGH... COMMUNITY AND WORKERS' CO-OPS

- Set up a Ministry of State for Cooperatives to co-ordinate services such as funding, marketing and research for co-ops.
- Establish an independent board drawn from the co-operative sector to determine the viability of co-ops.
- Provide seed capital to encourage creation of co-ops and worker ownership of viable firms unneccesarily abandoned.
- Give workers and communities the right of first refusal in the purchase of assets of viable closing firms.

NEW OPPORTUNITIES THROUGH... FARMING

- Eliminate the federal taxes on farm fuels up to 40¢ a gallon.
- Ensure grain prices cover the full cost of production including the cost of massive freight rate increases.
- Aggressively pursue an international grain pricing agreement.
- Set up a Western Grain Income
 Plan to provide for greater income
 stabilization.
- Establish a central selling agency for red meats.
- Ensure greater access for farmers to lower cost loans.
- Restrict the power of banks to force farmers out of business.
- Allow serious part-time farmers to claim up to \$20,000 in farm losses against other income.

NEW OPPORTUNITIES FOR... CANADA'S YOUTH

- Make a serious government commitment to setting out a timetable to reach the goal of providing a job for every Canadian willing and able to work.
- Expand apprenticeship training through an industry levy-grant system.
- Increase funding for postsecondary education with more flexibility in educational models to ease the bridge between school and work.
- Make sure government retraining programs provide a basic level of literacy for all young people to allow them the flexibility to adapt to new job opportunities or advanced training.
- Establish a Youth Initiative Fund which provides assistance to challenge young people to demonstrate how they would meet community and national heeds through projects to conserve energy; protect the environment; assist the elderly; expand and protect our natural resource base; improve community health facilities; and counsel this peer group in gaining employable skills.

NEW OPPORTUNITIES FROM... FAIR TRADE

- Ensure greater Canadian content agreements with foreign-owned corporations.
- Establish trade agreements for key industries which face unfair foreign competition.

NEW OPPORTUNITIES THROUGH... PRODUCTIVE PUBLIC INVESTMENTS

- Invest in Canada's natural resources through measures such as reforestation and salmanold enhancement.
- Provide municipalities with greater funding to undertake local economic initiatives.
- Develop new research and marketing services to aid small businesses, farmers and co-operatives.

At the same time, there have been thousands of opportunities — and jobs — lost in the last year because workers, and their communities, did not have the information

and financial assistance to rescue themselves.

THE OPPORTUNITY FOR CANADIAN

ANADIAN WOMEN deserve to see a future free of discrimination. We must see an end to the second-class status of women in Canada's economy.

Brian Mulroney and John Turner are willing to sacrifice women's concerns.

.nen in Canada are denied equal opportunities and remain the least secure members of our society:

- almost one in five single-parent women the sole supporters of their children — is unemployed;
- the average income of a woman in the paid workforce is 60 percent that of a man;
- three times more women than men are forced to work part-time;
- women who work in the home have no economic rights.
- a full 60 percent of our country's poor are women, primarily older women and single parents.

The Liberals and Conservatives have suddenly started talking about equality for women. But they still have no idea how to eliminate these inequities. Their answer for this, as for everything else, is to rely on 'the corporate sector' to make whatever changes are necessary — as long as they are profitable.

At a recent women's meeting, Brian Mulroney said: "There's going to be none of these improvements until such time as the economy is booming again."

But we can't wait. The desperation of a society in economic crisis, is reflected in the increasing number of battered women, abused children and victims of violent crime.

Mulroney went on to sidestep a question on whether the Conservatives would help narrow the gap between men's and women's wages by requiring companies doing business with the federal government to have equal pay for work of equal value.

John Tumer, at a recent meeting of Liberal women, said that he would not support compulsory affirmative action for women in the private sector, instead, he "prefers to negotiate such goals on the basis of goodwill".

'Goodwill', in the past, has done nothing for the women of Canada.

OF EQUALITY WOMEN.

New Democrats will continue the fight for women's equality.

Canadian women cannot wait for the 'corporate sector' to provide them with equal opportuniss. New Democrats will insist on equality for ...omen in Canada, now.

Only the New Democratic Party has a record of equal opportunities for women. New Democrats were the first to elect a woman provincial party leader. New Democrats were the first to elect a women as national party president. And the New Democratic Party is the only one in which women hold as many elected positions as men.

New Democrats believe that these opportunities for equality should be extended to all Canadian women. And we'll continue to fight for it — even after the election.

NEW OPPORTUNITIES FOR... WOMEN

- Ensure an active and systematic enforcement of the equal pay for work of equal value law.
- Extend mandatory affirmative action programs in both the public and private sectors.
- Ensure greater job protection from technological change.
- Provide greater financial assistance to help women get a start in small business and agriculture.
- Provide greater access to training and post-secondary education.
- Ensure part-time workers receive pro-rated benefits.
- Make child care accessible and affordable.
- Ensure adequate public pensions for all women.
- Increase funding for transition houses and advocacy centres to help battered wives seeking Jobs, legal services, housing and health care.
- Develop social and health services specifically to meet the special needs of rural women.

THE OPPORTUNITY PUBLIC

ANADIAN FAMILIES need universal, quality public services: pensions for our parents, education and family allowances for our children, health care for the whole family, unemployment insurance if we lose our jobs and a clean environment for future generations. These are the services Canadian families have paid their taxes for. And we expect our federal government to provide these services as a major priority.

Brian Mulroney and John Turner keep telling us we can't afford quality public services.

The Conservatives and Liberals are cutting off public services to ordinary Canadians to pay for their tax breaks to the privileged few.

The Conservatives' spokesman, John Crosbie, says: "We have to be tough, mean and nasty and do all kinds of unpleasant things." He went on to say that this would mean "...more means testing so that programs (such as family allowances and pensions) are not universal." And Brian

NEW OPPORTUNITIES FOR... AN ADEQUATE PENSION

- Establish pensions for all Canadians as a right.
- Make sure every elderly Canadian has an income at least equal to the poverty line.
- Give Canadians in the paid workforce an opportunity to provide for retirement through a fully portable, fully indexed Canada Pension Plan.
- Ensure all pension credits from public and private plans are shared equally by spouses.
- Introduce pension portability, protection for part-time workers and equal treatment for men and women in all pension plans.

TO RECEIVE QUALITY SERVICES.

Mulroney agrees with John Crosbie. In response to the drastic cuts in vital B.C. services, which especially affected women, he said: "Obviously, Bennett is going the right way."

John Turner also promises to increase giveaways to the privileged and, at the same time, "cut the deficit drastically" to pay for tax breaks to large corporations. This means fewer public services for Canadian families. In fact, he was the first to introduce cuts in public services like Medicare and education during his term as Finance Minister in the mid-70's.

New Democrats fought for public services in the past. We'll fight even harder in the future.

New Democrats won't allow cuts in the public services that Canadian families, like yours, need and deserve.

Ordinary Canadians remember that it was the New Democrats who introduced universal health care in North America.

Canadians also remember that it was the New Democrats who fought for, and won, universal public pensions.

There is more to be done: to ensure that elderly Canadians, particularly women, have adeuate pensions; to provide dental care for all canadian children; to properly fund our country's hospitals, and more.

NEW OPPORTUNITIES FOR... ETHNOCULTURAL COMMUNITIES

- Create a federal multiculturalism department.
- Increase multicultural representation on federal boards and commissions.
- Encourage establishment of multicultural research and resource centres.
- Ensure adequate funding of second language training.
- Establish affirmative action programs in the federal public service for visible minorities.
- provide appropriate redress and compensation for injustices against Japanese and Chinese Canadians.

Canada is a nation of caring people. We want to see our citizens well cared for when they're too young, too weak, or too old to fend for themselves. We don't want to see Canadians tossed aside when they retire, lose their jobs, fall ill or have an accident.

Now, more than ever before, we need New Democrats in Parliament fighting for the quality public services Canadian families need and, indeed, are paying taxes to receive.

NEW OPPORTUNITIES TO... SAVE OUR ENVIRONMENT

- Ensure cleanup of toxic waste dumps by industry and government and adequate compensation for victims of pollution.
- Establish a federal Safe Drinking Water Act.
- Reduce allowable level of auto emissions and ban lead in gaso-line
- Review federal testing and approval of pesticides.
- Provide necessary access and funding for public input into environmental impact studies.
- Encourage development of "clean" energy by shifting funding from conventional energy sources.

NEW OPPORTUNITIES FOR...QUALITY HEALTH CARE AND EDUCATION

- Restore federal funding and service cuts of recent years.
- Provide for escalating penalties to provinces that extra-bill and charge user fees.
- Introduce new preventive health initiatives.
- Encourage all provinces to expand their universal health care services such as pharmacare for seniors and children's denticare.
- Provide financial aid to part-time students most of whom are women.
- Expand funding for women seeking an education needed to pursue non-traditional jobs.

THE OPPORTUNITY TO BENEFIT FROM A FAIR TAX SYSTEM.

ANADIANS LIKE YOU are willing to pay their share of taxes — as long as it's fair. We want to see a tax system which does not allow wealthy Canadians to avoid paying taxes. And we want a system which doesn't tax the income of poor Canadians.

Brian Mulroney and John Turner will continue to pamper the privileged.

What ordinary Canadians have today is a very unfair tax system, where thousands of people who earn more than \$50,000 a year don't pay a cent in income taxes, and hundreds of people who earn \$200,000 a year are allowed to duck out on income tax. This unfair system also taxes small businesses and farms at a much higher rate than large corporations, and taxes pensioners and unemployed workers while the wealthy pay nothing.

The Liberals and Conservatives continue to ignore this injustice. In fact, they plan to make it even worse. John Tumer recently said that ordinary Canadians may have to face more tax increases in the near future.

New Democrats will continue to fight for a fair tax system.

New Democrats, and most Canadians, agree that co-operation is most likely among people who feel they are being treated fairly. And we cannot build a new future without asking all Canadians to pay their fair share to support our public services.

New Democrats will speak out to ensure that wealthy Canadians pay their fair share of income taxes.


And New Democrats will fight against taxing Canadian families whose income is below the poverty line.





NEW OPPORTUNITIES FOR... PEACE AND NUCLEAR DISARMAMENT

- Restrict the sale of nuclear technology and fuel.
- Increase funding for disarmament education and research in Canada.
- Promote a nuclear weapons freeze by the U.S. and U.S.S.R.
- Support a "no first use" pledge by NATO and the Warsaw Pact.
- Work at the United Nations for a comprehensive nuclear weapons test ban, a space weapons ban and a global referendum on disarmament.
