

# Lower Income Taxes for Saskatchewan Families

A competitive tax structure that puts more of your money back in your pocket and rewards entrepreneurial private sector business investment is the foundation of a growing economy.

That's why lower taxes form the foundation of the Saskatchewan Party plan to grow Saskatchewan by 100,000 people in ten years.



After 12 years of NDP government, Saskatchewan families pay too much tax and low income families pay the highest taxes in Canada.

A family of four in Saskatchewan starts to pay provincial income tax when family income reaches \$21,000.

The same family in Alberta doesn't start paying provincial income tax until family income reaches \$34,500.

That's a huge difference and it's a major barrier to growing Saskatchewan. A Saskatchewan Party government will close the gap and cut taxes for everyone in Saskatchewan by:

- Increasing the basic personal exemption from \$8,000 to \$10,000 over four years; and
- Increasing the child tax credit from \$2,500 to \$3,000.

When our Grow Saskatchewan plan is fully implemented, a family of four in Saskatchewan won't start paying provincial income tax until family income reaches \$26,000.


As a result, every person in Saskatchewan who pays provincial income tax now will pay lower taxes. And thousands of lower income families will be removed from the tax rolls and therefore won't pay any provincial income tax at all.

#### The result will be:

- Lower taxes for everyone;
- More money in your pocket; and
- Competitive income tax rates that help grow Saskatchewan by 100,000 people in 10 years.

After 12 years of NDP government, Saskatchewan families pay too much tax. A Saskatchewan Party government will lower personal income taxes for everyone in Saskatchewan.

# Reducing the Property Tax Burden

Under the NDP, Saskatchewan people face some of the highest property taxes in Canada. That's a major barrier to growing Saskatchewan.

#### A Saskatchewan Party government will cut the education portion of property taxes by:

1. Making education property taxes on primary residences fully deductible against provincial income for tax purposes — a first in


Under the Saskatchewan Party plan, homeowners will receive a provincial income tax reduction of as much as \$150 for every \$1,000 of education property tax they pay.

2. Cutting education property tax on agricultural land by 15 percent. Under the Saskatchewan Party plan, owners of agricultural land will have their education property tax bill cut by 15 percent at the time the property tax bill is paid.

Lower property taxes make Saskatchewan communities more competitive in attracting new people because homeowners and farm families will keep more of their hard earned money.

Lowering property tax for agricultural land improves the bottom line of farm families and increases the value of farmland.

Together, these two education property tax cuts will play an important role in achieving the Saskatchewan Party's goal of growing Saskatchewan by 100,000 people in ten years.





# Keeping Young People in Saskatchewan



Too many young people are leaving Saskatchewan. A Saskatchewan Party government will give them a reason to stay.

The Saskatchewan Party's Grow Saskatchewan Plan is designed to stimulate the creation of thousands of new jobs for young people here in Saskatchewan.

But we also need a competitive tax system that gives young people an incentive to work and live in Saskatchewan.

That's why a Saskatchewan Party government will establish the lowest income tax rates in Canada for graduating post-secondary students.

Under our Grow Saskatchewan Plan, graduating post-secondary students who choose to work and live in Saskatchewan will be eligible for a \$7,000 annual income tax deduction every year for a maximum of four years after graduation.

Post-secondary graduates who stay in Saskatchewan will receive a \$7,000 income tax deduction for up to four years.

#### The Saskatchewan Party Plan:

Graduating post-secondary students will receive a provincial income tax cut of between \$770 and \$1,050 per year for up to four years after graduation.

That's in addition to the \$10,000 basic personal exemption that every person in Saskatchewan will receive under our provincial income tax reduction plan.

When fully implemented, post-secondary graduates who choose to work and live in Saskatchewan will pay no provincial income tax on their first \$17,000 of income for four years. That's more than double the \$8,000 exemption that the NDP has in place today.



A married couple that chooses to work and live in Saskatchewan will pay no income tax on the first \$34,000 of family income for up to four years after graduation.

The Saskatchewan Party is serious about growing Saskatchewan by 100,000 people in ten years.






## Rebuilding Saskatchewan's Infrastructure

### **Investing in Our Communities**

Municipal governments are telling us they need the autonomy, legislative authority and financial ability to make decisions and provide services based on local priorities rather than being told what to do by the provincial government.

Municipal infrastructure is the economic base of the province and the foundation of every community. Growing Saskatchewan by 100,000 people in 10 years will require high quality municipal services, vibrant communities, strong local infrastructure and competitive property taxes.



### A Saskatchewan Party government will invest in communities by:

- increasing provincial government funding to municipalities by \$80 million over 4 years to enable local governments to provide high quality services while keeping property taxes as low as possible;
- working with all municipalities to provide more local control over the provision of local services; and
- negotiating a new Municipal Revenue Sharing Agreement between municipalities and the province based on provincial own source revenues and the municipality's ability to raise local property tax revenue.



### Restoring a World-Class Transportation System


A safe and reliable transportation system is one of the most fundamental building blocks of a growing economy. For most of the past 12 years, the NDP has ignored the critical need for a long-term transportation strategy and failed to make the investment necessary to build and preserve a world-class highway network.

### A Saskatchewan Party government will restore Saskatchewan's highway and transportation system by:

- committing \$1.2 billion over four years for highway and road construction and maintenance;
- completing a comprehensive evaluation of every highway in Saskatchewan to determine its role in achieving our goal of growing Saskatchewan by 100,000 people in 10 years;
- releasing a four-year plan clearly showing the government's road construction and maintenance program;
- developing a strategy to encourage the sustainable development of the short line rail industry to assist in meeting the transportation challenge in rural Saskatchewan;
- working with the Saskatoon and Regina Airport Authorities to promote investment and economic growth by enhancing air service to and from Saskatchewan; and
- promoting new highway construction technology designed to meet the demands of Saskatchewan's climate and large scale truck traffic.



# Building a Sustainable and Profitable Agriculture Industry



Agriculture is the most important industry in Saskatchewan. But it has been hard hit in recent years by drought, low commodity prices, dramatic increases in U.S. farm subsidies and now the closure of the American border to most Canadian beef exports.

As a result of the lack of leadership by the NDP, our agriculture industry has struggled and our rural communities have paid the price.

#### The NOP Record:

- X During last year's devastating drought the NDP dramatically increased crop insurance premiums and eliminated spot-loss hail coverage.
- 🐰 The NDP has failed to negotiate a new long-term safety net program with the federal government.
- X The NDP has stumbled through the BSE crisis with no plan for supporting the livestock industry.
- The NDP has no long-term agriculture strategy and no vision for the future of agriculture in Saskatchewan.

A Saskatchewan Party government will implement a 10point plan to double the value of agriculture and agri-business production in Saskatchewan over ten years by:

- **Enhancing the Saskatchewan Crop** Insurance Program and working to negotiate a sustainable long-term safety net program with the federal government and producers;
- Reducing education property tax on agricultural land by 15% and increasing the provincial government's share of K-12 education costs to 50% of total costs;
- Establishing a \$300 per head low interest cash advance to address the serious cash flow problems facing producers due to the BSE crisis;
- Eliminating the Small Business Tax for all businesses including farm businesses;
- Cutting the corporate capital tax by 50% to encourage new investment in the agricultura industry;
- Negotiating the right for producers to have a choice in marketing grain production through the Canadian Wheat Board, in the open market or for use in local value-added enterprises;
- Investing in new water and irrigation infrastructure to promote more valueadded and intensive production in Saskatchewan;
- Ensuring government regulations facilitate the flexibility to develop value-added niche market products;
- Removing bureaucratic barriers to valueadded private sector investment in the agriculture industry; and
- Establishing provincial Centres of Excellence to promote and facilitate innovation and research in development of value-added processing in Saskatchewan.



### Stopping the NDP Attack on Seniors



### After a decade of NDP government, Saskatchewan seniors are under attack:

- Saskatchewan seniors pay some of the highest property taxes in Canada because the NDP has slashed grants to our cities and towns;
- Under the NDP, Saskatchewari's low-income seniors pay the highest personal income tax rates in Canada:
- \* In the 2002 provincial budget, the NDP attempted to increase long term care fees for seniors by as much as 135%;
- X Saskatchewan has the highest violent crime and property crime rates in Canada;
- Seniors continue to endure the heartache of watching their children and grandchildren leave Saskatchewan because the NDP has done nothing to address the worst population loss record in Canada; and
- Saskatchewan seniors suffer on the longest hospital waiting lists in Canada.

#### A Saskatchewan Party government will stop the NDP attack on seniors by:

- Reducing income taxes for seniors and removing thousands of seniors from the income tax rolls:
- Cutting education property taxes for seniors who live in their own homes;
- Increasing funding to municipalities by \$80 million over four years to help prevent property tax increases;
- Stopping the NDP from ever again attempting to impose massive long-term care fee increases;
- Stopping the NDP from increasing utility rates to pay for multi-million dollar business losses in Ontario, Atlanta and Australia;
- Bringing crime rates down by honouring the NDP's broken promise to hire 200 new police officers:
- Recruiting and hising more doctors, nurses and other healthcare professionals to improve frontline patient services and reduce waiting lists; and
- Growing Saskatchewan by 100,000 people in tan years so more of their children and grandchildren can remain in Saskatchewan.



# WorkFirst — Welfare Reform that Gets People Back to Work

The Saskatchewan Party believes in the digrity of work and in the goal of moving fully-employable welfare recipients from welfare to work.

Our Grow Saskatchewan plan will stimulate new job growth. New jobs are the key to moving fully employable welfare recipients from welfare to work.

### The Saskatchewan Party's WorkFirst Plan will:

- Require fully employable welfare recipients to work in order to qualify for welfare benefits;
- Shift the goal of welfare offices across Saskatchewan from paying cash assistance to facilitating the transition of fully employable welfare recipients from welfare to work quickly; and
- Reduce the number of fully-employable welfare recipients by 25 percent over four years.



# Cracking Down on Crime

In 1999, the NDP promised to hire 200 new police officers. They broke that promise.

Meanwhile, Saskatchewan has remained the crime capital of Canada. After 12 years of NDP government, Saskatchewan has the highest violent crime rate in Canada, the highest property crime rate in Canada and one of the highest car theft rates in North America.

Saskatchewan people deserve to live in safe neighbourhoods and safe communities.

### **Boot Camps for Repeat Young Offenders**

Repeat young offenders need to learn respect for themselves, for others and for other people's property. A Saskatchewan Party government will establish Strict Discipline Young Offenders Camps, sometimes known as boot camps, for chronic young offenders involved in property crimes and car thefts.

### More Police Officers on the Streets

A Saskatchewan Party government will fulfill the NDP's broken 1999 election promise to hire 200 new police officers.

### **Protecting Children from Sexual Predators**

A Saskatchewan Party government will pass tough new laws to protect children from sexual predators by fining pimps and johns a maximum of \$25,000 and sending them to jail for a minimum of six months on the first conviction.

#### **Compensating Victims of Crime**

in 2002, the NDP drained \$750,000 out of the Victims of Crime Compensation Fund. This money comes from a surcharge on court-imposed fines and was supposed to be used to compensate victims of crime.

A Saskatchewan Party government will ensure that all funds raised for the Victims of Crime Fund are paid out to victims of crime and not taken by the government.

#### Justice System Reform

Saskatchewan's courts are clogged with expensive and often bitter property, marital and child custody disputes.

A Saskatchewan Party government will encourage the expanded use of out-ofcourt mediation services to reduce the cost and the time required to settle many legal and family disputes.






## Growing Saskatchewan With Quality Health Care


Our Grow Saskatchewan Plan will re-establish Saskatchewan as a leader in providing excellent, accessible, publicly-funded health care in accordance with The Canada Health Act.


In 1999, the NDP promised to reduce surgical waiting lists by 30 percent and hire 500 new health care providers. Instead, waiting lists have increased by 30 percent and Saskatchewan has lost more than 200 nurses.

The Saskatchewan Party believes that all Saskatchewan residents should have access to quality and timely publicly funded health care. That's why health care will be a priority for a Saskatchewan Party government.

We need to reduce our surgical wait times, improve front-line patient care and focus on advanced medical research.








### A Saskatchewan Party government will:

- Invest \$100 million to build a new state-of-the-art integrated health science facility at the University of Saskatchewan to help attract and retain doctors, nurses and other health care providers;
- Add 240 new nurse training seats and increase the overall number of training seats to address the growing shortage of health care professionals;
- Implement an aggressive recruitment and retention program to attract and keep doctors, nurses and other health care professionals;
- Increase the provincial share of health care capital construction projects to 85% (from its current level of 65%) to ensure health facilities are built or upgraded based on need instead of local financing capability;
- Improve the provincial emergency medical response system in Saskatchewan including the introduction of a centralized air ambulance helicopter service to speed emergency medical response times and provide professional trauma service in rural Saskatchewan;
- Establish a Health Care Bill of Rights and a permanent Health Care Commissioner to clearly define the relationship between the health care system and the people of Saskatchewan;
- Build strategic alliances with centres of excellence in Canada and with world-class centres like the Mayo Clinic for specialty diagnostic and treatment services;
- Create an Institute for Research and Treatment of Diabetes and Nephrology that is fully accessible by aboriginal people; and
- Support the creation of a dedicated light beam for advanced medical research at the Canadian Light Source in Saskatoon at the University of Saskatchewan.



# Investing in World-Class Education



#### K-12 Education

### A Saskatchewan Party government will:

- Stabilize K-12 school enrollments and keep teachers in Saskatchewan as our population grows by 100,000 people in ten years;
- Increase the provincial government's share of funding to K-12 education from its current level of about 40% up to 50% within our first term;
- Cut the education portion of property tax by allowing it to be deducted from taxable income for provincial income tax (See page 5 for details);
- Cut the education portion of property tax on agricultural land by 15% (See page 5 for details);
- Implement the School Plus concept in all school divisions and promote strong community and parental choice in the planning, decision-making and delivery of K-12 education;
- Encourage multi-use educational facilities to make more efficient use of each tax dollar;
- Strengthen the provincial network of schools, regional colleges, technical institutes and universities and expand on line K-12 education programming to expand education options in remote and less populated areas; and
- Integrate provincial and K-12 library systems through multi-use facilities and shared resources to cost-effectively increase public access and the quality of library services across Saskatchewan.

The Saskatchewan Party plan to grow Saskatchewan by 100,000 people in ten years means more students and a growing tax base that will enable the province to invest in education while keeping tax rates low.

Growing Saskatchewari by 100,000 people will create the opportunity to invest in the renewal of educational facilities, develop a comprehensive province-wide distance education system, ensure students have access to the post-secondary educational opportunities they need to work in the new knowledge-based economy and restore a secure future for Saskatchewan teachers.

### Post Secondary Education A Saskatchewan Party government will:

- Increase operating funding to Saskatchewan's universities, SIAST and regional colleges by 5% per year over four years;
- Invest \$100 million in a new Health Sciences Facility at the University of Saskatchewan to provide stateof the art medical research opportunities and more training spots for much-needed doctors, nurses and other health care professionals;
- Offer graduating post-secondary students who choose to live and work in Saskatchewan the lowest income taxes in Canada by cutting their provincial income taxes by up to \$1,050 per year for up to four years after graduation (See page 6 for more info);
- Remodel the Saskatchewan Student Loan Program to ensure the children of middle-income families have access to student loans:
- Expand on-line university and college course programming to facilitate more post-secondary learning opportunities close to the student's home community and to increase the post-secondary options available to full-time workers and students with disabilities:
- Work with business, industry and labour to share the costs of post-secondary and skills-training programs and to ensure graduating students are equipped to work in the new knowledge-based economy; and
- Link educational institutions with private sector employers to ensure graduating students have the skill set necessary to work successfully in the new knowledge-based economy.



# Refocusing Saskatchewan's Crown Corporations

Saskatchewan's Crown Corporations have made a tremendous contribution to the development of Saskatchewan. - Ensure that Saskatchewan continues to have a publicly-administered, government-owned basic auto insurance program; and
- Oppose any further deregulation of the market for electricity that has caused major electricity rate hikes and power shortages in other jurisdictions.

These eight steps will lay the foundation for the growth of our major utility businesses through service to Saskatchewan people in Saskatchewan as our province grows by 100,000 people in ten years.



### **Building Partnerships to Grow Saskatchewan**

### Building a Partnership with Municipalities

Urban, rural and northern municipalities will play a key role in growing Saskatchewan. Partnerships between the provincial government and municipalities provide much of the local infrastructure upon which the economic base of our province is built.

#### A Saskatchewan Party government will strengthen that partnership with municipalities by:

- Increasing provincial government funding to municipalities by \$80 million over 4 years to enable local governments to provide high quality services while keeping property taxes as low as possible;
- Working with all municipalities to provide more local control over the provision of local services; and
- Negotiating a new Municipal Revenue Sharing Agreement between municipalities and the province based on provincial own-source revenues and the municipality's ability to raise local property tax revenue.

### Building a Partnership with First Nations

Saskatchewan's success over the next decade hinges on the success of our rapidly growing First Nations population. First Nations people and businesses must be full partners in the growth and governance of Saskatchewan with equal opportunities, rights and responsibilities.

### A Saskatchewan Party government will build a partnership with First Nations based on:

- Recognition that treaty rights must be respected and honoured by the federal government within the context of the economic, social and political climate of the 21st century;
- Support for the principle of responsible aboriginal self-government where self-government is defined as community or local government that is democratic and fully accountable;
- First Nations as full partners, investors and owners in the economic development of Saskatchewan; and
- Support for First Nations/private sector partnerships in major projects including:
  - value-added expansion of our rich granium resources;
  - participation in infrastructure development including the financing and construction of local infrastructure, highways, pipelines and electrical transmission assets; and
  - new opportunities for value-added growth of our forestry, agriculture and tourism industries.

### **Building a Partnership with Labour**

All working people, whether they belong to a union or not, will play an important part in achieving the shared goal of growing Saskatchewan by 100,000 people in 10 years.

Working men and women will also be some of the biggest winners as Saskatchewan grows.

Lower taxes and a more business friendly environment will attract new investment and stimulate new job creation.

More jobs in Saskatchewan means more work for everyone including unionized employees.

But, Saskatchewan's current labour laws are creating a major barrier to new private sector investment and job growth in Saskatchewan.

Without new investment capital, businesses can't grow. As a result, Saskatchewan is losing people, jobs and investment to other provinces.

# A Saskatchewan Party government will introduce fair and balanced labour laws that respect and protect the rights of workers while removing the current barriers to business growth and investment by:

- Requiring that union certification or de-certification is supported by a majority of employees through
  a secret ballot vote in every workplace after both the union and management have had the opportunity to
  publicly communicate their positions to employees;
- Eliminating union preference tendering on all government and Crown Corporation construction contracts to restore competition and lower government construction costs;
- Reviewing the mandate and operation of the Workers' Compensation Board to ensure the WCB is serving
  injured workers efficiently and effectively while being fully accountable to the employers who pay the bills;
- Working with representatives from organized labour to adopt a new collaborative approach to collective bargaining that focuses on problem solving and mutual gains for management and employees.

The result will be an economic environment where private sector investment is welcomed and new jobs are created within a framework of fair labour laws, reasonable regulation and democratic workplaces.

A fair and balanced labour environment is a critical part of the foundation upon which Saskatchewan will grow by 700,000 people in ten years.

### Building a Partnership with Business

Small businesses creates most of the new jobs in Canada. Saskatchewan needs more jobs to achieve our goal of growing by 100,000 people in 10 years. Small businesses need lower taxes, an investment-friendly environment, less bureaucratic red tape and a government that works with them instead of against them.

### That's why a Saskatchewan Party government will make Saskatchewan the best place in Canada to start or grow a business by:

- Making Saskatchewan the first Small Business Tax-Free Zone in Canada;
- Attracting new business investment by cutting the corporate capital tax on investment in half:
- Conducting a full Government Efficiency Review to eliminate government waste and red tape and to ensure

With government operating efficiently and focused on encouraging private sector job growth, small businesses will be the primary engine driving the growth of Saskatchewan by 100,000 people in ten years.




### A Return to Accountable Government

Since Lorne Calvert was appointed Premier in 2001, his NDP government has piled up three straight deficit budgets and added more than \$1.6 billion in new provincial debt. Saskatchewan's provincial debt is now higher than it was when the NDP took power in 1991.

A Saskatchewan Party government will return Saskatchewan to balanced budgets and make government fully occountable by:

- introducing strong balanced budget legislation that ends the NDP's budget deficits;
- moving to budgeting based on Summary Financial Statements that present a complete picture of government finances;
- establishing set election dates every four years; and
- implementing free votes in the legislature so that MLAs can represent the views of their constituents rather than simply toeing the party line.





### Cutting Waste and Mismanagement in Government

Saskatchewan people don't believe they are getting good value for the tax dollars they are paying every month. It's not hard to understand why. The NDP has gambled and lost millions of dollars on risky foreign business ventures in places like Atlanta and Australia.

Meanwhile, the real funding priorities of health, education and community infrastructure are left to fight over shrinking tax dollars. Families and businesses expect their government to do something about waste and mismanagement.

A Saskatchewan Party government will respond by providing effective and efficient government at the lowest possible cost.

A Saskatchewan Party government will launch a comprehensive Government Efficiency Review of every program, department, board, agency, commission and Crown Corporation based on the following five questions:

- Does it serve a compelling public interest?
- Is it affordable within the fiscal environment of the province?
- Is it being delivered in the most efficient way possible?
- Is it accountable to the taxpayer?

### A Return to Balanced Budgets

### Step One:

### Fixing the NDP Mess and Balancing the Budget

A Saskatchewan Party government is committed to returning Saskatchewan to balanced budgets.

Over the past three years, the Calvert NDP has introduced three straight deficit budgets and added \$1.6 billion in new government debt in Saskatchewan. Worse, the NDP has attempted to masquerade its massive deficits as balanced budgets.

### Step Two:

### Implementing Our Grow Saskatchewan Plan

The annual cost of the Saskatchewan Party tax reduction plan is \$260 million when fully implemented by the fourth year of our term. The annual cost of the Saskatchewan Party spending measures is \$100 million when fully implemented by the fourth year of our term. These are specific spending measures, on top of other spending increases that will be necessary in priority areas like health and education.

A growing economy will result in a growing tax base and higher revenues for Saskatchewan. The Saskatchewan Party plan assumes a real economic growth rate of 3.5 per cent per year. This will increase provincial revenues by about \$200 million per year, or \$300 million over four years — allowing a Saskatchewan Party government to return the province to balanced budgets and then fully implement our plan by the fourth year of our term within a balanced budget.

A Saskatchewan Party government is committed to implementing all the measures outlined in this platform within our four-year term of office.


However, we will not implement any new tax cut or spending increase that will result in an increased deficit. That means before we can begin to implement our tax reduction plan and proceed with the new spending measures outlined in this platform, we will have to clean up the NDP's financial mess and return the province to balanced budgets.

That means, unlike the NDP, we WILL account for all of the revenues and expenditures of government including our Crown Corporations and we WILL NOT use imaginary funds like the NDP's so-called 'fiscal stabilization fund' to try to hide a deficit.

This will be possible through disciplined management of government departments, Crown Corporations focused on growing Saskatchewan and increased government efficiency. 


